Panel Questions and Comments

How will the changes be attached to the masonry building? There are existing wood components, and the shutters, gate and trellis would be attached to the wood. The shutters are to protect the exit and security and safety for those using the building but could be removed in the future pending safety in the area.

Fire shutters are required for exit protection according to BC Building Code for Life Safety., has placing them on the interior of the windows been considered? Due to the frequency of break-ins the exterior is preferable for security reasons. The shutters would be open during business hours and the windows are transparent when shutters are open.

Were alternatives looked at to provide fire safety for users of the building instead of adding the shutters? Yes. This addition adds a secondary exit being added to the building.

Could the new exit and landing look open to the stairs and can the public access the stairs at anytime? Public could congregate on the landing instead of the stairs; the landing is also accessible via the second level of the parkade. Once the stairwell is installed, the public could access the new entrance to Boomerang Court. The area is currently very hidden, and this project's design elements aim to open it up and make the area more visible. Will there be a fence along the property line? The current fence will remain until the project is completed and then removed due to security. The stairs could be closed off to prevent public gathering on the stoop.

What necessitated pushing out the lift and obscuring the windows as they are identified as character-defining elements? The requirement for accessibility in front of the lift. What will be happening with those windows that do not have shutters proposed? There is no security issue for the second story windows, but this is not necessary. The stairs and elevator lift are not relying on the masonry building for stability. The landing will be transparent to create sense of openness and continuity. Could the access to the stairwell have been made smaller? No, between the accessibility requirement and stair requirements, this was not possible. The footprint cannot be smaller, but the guard rail could be reduced.
