PARKS AND RECREATION FEES BYLAW

A BYLAW OF THE CITY OF VICTORIA

(Consolidated to include Bylaws No. 08-073, 09-055, 10-036, 10-053, 11-047, 12-064, 13-048, 14-065, 15-054, 19-036, 20-028, 22-006, 22-032)

The purpose of this Bylaw is to replace the Recreation Facilities Admission Fees Bylaw and the bylaws for the Leisure Services and Recreation Facility Reserve Fund.

Under its statutory powers, including sections 8 and 194 of the *Community Charter*, the Council of The Corporation of the City of Victoria enacts the following provisions:

Title

1 This Bylaw may be cited as the "RECREATION FEES BYLAW".

Definitions

2 In this Bylaw

"adult"

means an individual who is 18 years of age or older and under the age of 60 years;

"adult organization"

means an individual or group, incorporated or unincorporated,

- (a) the primary objective of which is to provide individuals with sport, recreational, and social activities, and
- (b) over 50% of whose participants are 18 years of age or over;

"child"

means an individual who is 5 year of age or older, and under the age of 13 years;

"community centre" means a facility where community programming is delivered by a neighbourhood association;

"community programming" means no charge programs or events provided by a neighbourhood association for residents of its neighbourhood, including but not limited to public markets, fitness and sport programs, arts and culture programs, community meetings, and picnics;

"community use"

means the use of festival equipment for a festival, celebration, or special event located within the City;

"community use time"

means the time available, under agreement, for the City of Victoria's use of the Save-on-Foods Memorial Centre:

"Crystal Pool and Fitness Centre"

means the swimming pool and fitness centre located at 2275 Quadra Street;

"exempt neighbourhood association" means a neighbourhood association that does not have no charge access to a community centre in its neighbourhood;

"family"

means more than one and no more than 5 individuals, at least one of whom is an adult, who attend a recreation facility together;

"festival equipment"

means the City's portable equipment that is maintained

- (a) by the City's Parks, Recreation, and Facilities Department,
- (b) for the purpose of renting to festivals, celebrations, and special events;

"GST"

means the goods and services tax payable under Part IX of the *Excise Tax Act* (Canada);

"minor organization"

means an individual or group, incorporated or unincorporated,

- (a) the primary objective of which is to provide individuals with sport, recreational, and social activities, and
- (b) whose participants are under the age of 18 years;

"neighbourhood association" means a non-profit organization that meets regularly to discuss land use matters, which receives operational grants from the City of Victoria, and which is recognized by the City of Victoria as a partner in providing community programming;

"non-community use"

means the use of festival equipment for

- (a) a festival, celebration, or special event located outside of the City, and
- (b) for not longer than 96 consecutive hours;

"non-prime time"

- (a) in relation to Royal Athletic Park means between 8:00 a.m. and 11:00 p.m. on Mondays, Tuesdays, Wednesdays, and Thursdays, where those are not a statutory holiday;
- (b) in relation to Save-on-Foods Memorial Centre means
 - (i) between 6:00 a.m. and 3:00 p.m. on school days defined by School District #61, and
 - (ii) between 6:00 a.m. and 8:00 a.m. on non-school days;

"non-spectator event"

means an event involving only direct participants confined to the playing surface of Royal Athletic Park;

"Park Furnishing Dedication Program"

means a program established by the City to allow citizens to dedicate a park furnishing in City parks or public places to honour the memory of a person or event:

"preschool"

means an individual who is under the age of 5 years;

"prime time"

- in relation to Royal Athletic Park means between 8:00 a.m. and 11:00 p.m. on Fridays, Saturdays, Sundays, and statutory holidays;
- (b) in relation to Save-on-Foods Memorial Centre means
 - (i) between 3:00 p.m. and midnight on school days defined by School District No. 61, and
 - (ii) between 8:00 a.m. and midnight on non-school days;

"Royal Athletic Park"

means the outdoor sports facility located at 1014 Caledonia Avenue;

"Save-on-Foods Memorial Centre"

means the sports and entertainment facility located at 1925 Blanshard Street;

"senior"

means an individual who is 60 years of age or older;

"spectator event"

means an event having spectators in the seats or at the concourse areas of Royal Athletic Park;

"sports field"

- (a) means an outdoor space owned and maintained by the City for the purpose of outdoor sporting activities;
- (b) does not include Royal Athletic Park;

"youth"

means an individual who is 13 years of age or older and under the age of 18 years.

Fees

- 3 (1) A person who enters a City recreation facility, sports field, or park, uses City equipment, supplies, or festival equipment, films in or on City property, or participates in the Park Furnishing Dedication Program, must pay the applicable fees and comply with the regulations set out in Schedule A to I attached to this Bylaw;
 - (2) Subsection (1) does not apply to officers, employees, and agents of the City while they are acting in the course of their duties.

(3) Subsection (1) does not apply to exempt neighbourhood associations in relation to the fees set out in Schedule C attached to this Bylaw.

Offence

A person who contravenes a provision of this Bylaw is guilty of an offence and is liable on conviction to the penalties imposed under the *Offence Act*.

Repeal

- **5** The following Bylaws are repealed:
 - (a) Bylaw No. 92-121, the Recreation Facilities Admission Fees Bylaw;
 - (b) Sections 3 and 4 of Bylaw No. 92-175, the Sports Facility Reserve Fund and Recreation Fees Bylaw.

Commencement

- **6** Sections 3 and 5 take effect on the later of the following dates:
 - (a) September 1, 2006;
 - (b) the date this Bylaw is adopted.

- 1. All Dedication are subject to a 10-year term, and availability as determined by the City's Parks, Recreation and Facilities department.
- 2. The fee for a renewal term shall be equal to the fee of the same or equivalent item shown in the above table.
- 3. The Park Furnishing Dedication Program may include park benches, picnic tables, drinking fountains, games tables, or other furnishings designated by the City's Assistant Director of Parks, Recreation and Facilities.
- 4. The City shall apply the following formula to determine the donation fee for a park furnishing:

Furnishing Capital Cost (Purchase, fabrication, bronze plaque, and installation)	+	10-year Maintenance Contingency (25% of Amenity Capital Cost)	+	Administration Fee (\$250)	=	Total Cost of Dedication
