Applications must be completed annually by December 15th of each year for the following licensing year, by the Passenger Directed Vehicle company. Annual licence fees are due by January 15th.

Companies will hold one business licence for all licensed Passenger Directed Vehicles. Fees are calculated based on the number of, and types of, passenger directed vehicles being licensed.

When additional passenger directed vehicles begin operating after the annual licence fee for any year is paid, an additional application and supporting documentation must be submitted at that time. Any additional licence fees will be pro-rated based on the number of months remaining in the current licensing year.
